Current CLSI interpretive breakpoints may not predict clinical efficacy. Only strains with MIC  $\leq$ 1.0 may be regarded as fully susceptible. Strains with MICs 2.0-4.0 should be considered to have dose-dependent susceptibility. A cefepime MIC = 8 has been associated with clinical failure.
